## **Draft Meeting Minutes**

#### 3. CIIS Presentation

Sean Thakkar presented on the Connecticut Criminal Justice Information System. Sean provided an update as to where the current system is and where it will be going in the next several months. Sean stated that he believed that CJIS would be capable of taking a form, electronic or manual, and recording the traffic stop data in the system. CJIS is capable of collecting manual forms, e-tickets and CAD system information. The end user will be capable of manipulating the data for analysis and reports.

A general discussion about the CJIS system ensued prior to the end of the presentation.

### 4. Alvin W. Penn Act Overview

Jim Fazzalaro provided a legislative update and it was determined that a working group should be formed to address many of the concerns about the current proposed legislation.
